Furthermore, preliminary general and safety instructions are given to the participants when they inscribe for the activity and later in a safety-orientated briefing before starting the course, which is held by our specialized and trained staff. **The briefing consists in a detailed description of all park activities, of the correspondent locations, and of the rules of action to be followed when doing the activities in the forestry environment (standard and emergency situations). Additionally, the participant receives detailed instructions on the use of the Personal Protective Equipment. The participant acknowledges and agrees that there is a risk intrinsic to these Activities, of which they have been informed. After having completed the briefing, should the participant not feel to be able to do the course in a safe and secure manner, they need to cancel their participation in order to obtain a refund of the entrance fee. By signing this document you confirm that you have read and completely understood the referred Terms and Conditions of the park.

Forestal Park will not assume any responsibility whatsoever for possible accidents which might occur during the activities as a consequence of false declarations by the participant regarding the requirements of participation or non-compliance of the safety instructions and park rules. *When experiencing any of these symptoms, you should not leave your home and you must call the telephone number enabled in your Region to consult the protocol to follow.
